Remarks

The kennel operator is responsible for taking any and all actions necessary to come into compliance.***

Inspection of the kennel took place on March 27, 2024. A total of 127 adult dogs located on the premises and 113 dogs located in the rescue kennel networks homes at the time of this inspection. The 2023 kennel license was viewed. The state forms exemption letter was viewed. The 2024 license is pending in Harrisburg. The inspection was performed with State Veterinarian Dr. Ward.

The inspection of March 27, 2024 is as follows:
