Remarks

***Actions which are directed to be taken are not all that may be required of the kennel operator to come into compliance.
The kennel operator is responsible for taking any and all actions necessary to come into compliance.***

The inspection of the kennel took place December 6, 2019. There was a total of 46 adult dogs and 5 puppies located on the premises at the time of this inspection. The 2019 kennel license and rabies certification letter were both viewed. This inspection was conducted with KCS Frey and State Veterinarian Dr. Ward.

The inspection of December 6, 2019 is as follows:

Act 207(c) / Regulation 21.41(a) -

Wardens viewed kennel records that were inconsistent with the number and types of dogs in the kennel at the time of this inspection. Both kennel owners were present and refused to offer assistance to verify the kennel records.

This Warden directs the kennel owner to take the following action(s):

Records to be maintained.--Every keeper of a kennel shall keep, for two years, a record of each dog at any time kept in the kennel. Such record shall show:

- (1) The breed, color, markings, sex and age of each dog.
- (2) The date on which each dog entered the kennel.
- (3) The full name and physical address at the time the dogs were received of the previous owner or kennel from whom the dog was received. This paragraph shall not apply to a boarding kennel.
- (4) The full name and physical address of the person or kennel to whom the dog belongs.
- (5) For what purpose each dog is kept in the kennel.
- (6) The date on which each dog leaves the kennel.
- (7) How the dog is dispensed. If the dog was transferred to another person or kennel, the record must state the full name and physical address of the person or kennel to whom the dog was dispensed.
- (8) The name, address and telephone number of the licensed doctor of veterinary medicine used by the kennel. Such record shall be legible and shall be open to inspection and may be copied by any employee of the department, State dog warden or police officer as defined by this act.

Complete records shall be kept on dogs within a kennel or being transported in a primary conveyance as prescribed by section 207 of the act (3 P. S. § 459-207), and the records shall be kept at the kennel location or, when applicable, shall accompany dogs being transported.

Act 401(c) -

Wardens attempted to complete the inspection by comparing the kennel records to the dogs in the kennel as they did not match. The kennel owners prevented us from continuing the inspection.

This Warden directs the kennel owner to take the following action(s):

Illegal to interfere.--It shall be unlawful for any person to interfere with any officer or employee of the department in the enforcement of this law.

Act 801 -

Wardens attempted to complete the inspection by comparing the kennel records to the dogs in the kennel as they did not match. The kennel owners prevented us from continuing the inspection.

This Warden directs the kennel owner to take the following action(s):

It is unlawful for any person knowingly to make any false statement or to conceal any fact required to be disclosed under any of the provisions of this act.

**A re-inspection will be conducted at a later date.
